2	Timeline p.2	Time	Can you precise which is the timing zone of reference ?	KSA time
3	Required Documents 1. Legal Documents p.10	Provision of legal documents for foreign companies	The prequalification documents mentions " in the event that any of documents (1.2-1.6) is not available, it can be provided later when the bids are submitted " Can you confirm that this is also valid for 1.1 Valid commercial registration certificate or registration application from the Ministry of Investment (SAGIA) ?	This document needs to be provided during the prequalification process.

4	Required Documents 1. Legal Documents p.10	Provision of legal documents for foreign companies	The provision of legal documents supposed a dully registered companie under the laws of the Kingdom of Saudi Arabia. Being a foreign company presently without any legally registerered company in the country, can these document be provided upon award of the contract ?	The SAGIA application form needs to be submitted during the prequalification process. The operator will be informed about the timing to submit the rest of documents.
5	--	Licences	Can we provide our marine operating licences?	This is acceptable
6	--	Project details	Due to the confidentiality and sensitivity of the current projects, we cannot release details of the projects.	The bidder needs to provide any supporting document demonstrating its experience at this stage to make Mawani comfortable that is complying with the criteria. The type and level of information can be decided by the bidder.
7	--	<i>Experience – Existing Project Form – Supporting Documents</i>	Can the authorities accept that we provide these details post award of the tender and signing of an NDA?	The information needs to be provided during the prequalification process. Mawani will treat confidentially all the information received that will only be used for the prequalification purposes.
8	--	Equipment	Can we provide IMO number in the column 'License Certificate Number?	This is acceptable

9	--	Equipment	Note the IMO number will not have an expiry date and as such can we leave the Expiry date as 'Not Applicable'?	This is OK
10	--	Equipment	Reference is made to page no. 18, "Establishment Resources Form"	bidder needs to list the owned/rented resources operated The IMO number is satisfactory as license number
